5. The chairman of the Awards and Installation Committee will present the name of the person nominated along with the attached Nomination Form to the Awards and Installation Committee.
6. There must be a quorum of no less than 10% of the general membership sitting as Awards and Installation Committee members to review the nomination.
7. The achievements and/or contributions of the person nominated for the Brotherhood Award shall be reviewed.
